Atosol 100 Solvent naphtha (petroleum), light arom.

Atosol 100 is a complex mixture of aromatic hydrocarbons which is predominately composed of C8–C10 aromatics in the form of alkylbenzenes from distillation of petroleum. More specifically, it contains significant amounts of trimethylbenzenes and methyl-ethylbenzenes. It contains less than 0.5 % ethylbenzene (CAS RN 100-41-4) and less than 0.1 % benzene (CAS RN 71-43-2) and naphthalene (CAS RN 91-20-3). This product may contain approximately 25 ppm BHT (CAS RN 128-37-0).
